



# QUAIL RIDGE RANCH STALLION BREEDING CONTRACT

AI/LIVE COVER

- 1) This agreement is by and between Quail Ridge Ranch, hereinafter referred to as "Quail Ridge" and \_\_\_\_\_ hereinafter referred to as "mare owner".
- 2) Mare owner desires to book a breeding to the stallion, \_\_\_\_\_. Name of mare to be bred is \_\_\_\_\_ registration number is \_\_\_\_\_. A COPY OF THE MARE'S REGISTRATION PAPERS MUST ACCOMPANY THIS CONTRACT.
- 3) Upon receipt of this signed contract, Quail Ridge will reserve for mare owner one season's stallion service to the above names stallion for the cover of the above names mare. The stallion service fee is \$\_\_\_\_\_ for the 200\_\_\_\_\_ breeding season. In consideration for a reservation to the above named stallion, mare owner shall pay to Quail Ridge a non-refundable deposit fee of \$\_\_\_\_\_, to accompany this breeding contract. The remaining balance will be \$\_\_\_\_\_, which mare owner agrees to pay in full prior to the time the mare is released from Quail Ridge premises. Said mare will not be released from Quail Ridge premises until all balances owing are paid in full. This includes, but not limited to fees for mare/foal care, veterinary services, farrier services, etc.
- 4) Mare owner hereby grants permission to Quail Ridge to check said mare for normal breeding soundness and to render any treatment or immunization which may be deemed necessary. The expense for these services will be charged to mare owner's account. Mare owner hereby agrees that Quail Ridge reserves the right to refuse service to any mare which, in the opinion of Quail Ridge appears to be diseased or unfit for breeding.
- 5) Quail Ridge guarantees a live foal, which is defined as a foal that stand and nurses after foaling. This guarantee will apply only if is notified within 48 hours after the time of loss of the fetus/foal. A written statement from a licensed veterinarian attesting to the spontaneous abortion of the fetus/still birth/death of the foal prior to standing and nursing MUST be received by Quail Ridge within 10 days of the occurrence of the loss for this guarantee to remain in effect. Upon receipt of such notification and written statement, mare owner received the right of return for the same mare or a mutually agreed upon substitute mare for the 200\_\_\_\_\_ breeding season without charge of additional stallion service. Mare owner will be responsible for any mare care charges incurred during the return season as outlined above. Live foal guarantee shall pertain only to mares that are pronounced safe in foal by a veterinarian within 90 days after last breeding date.
- 6) Mare owner hereby agrees to hold Quail Ridge harmless for any claim arising due from injury, illness and/or death to the mare and/or foal while mare/foal are under the care, custody and control of Quail Ridge. Should mare/foal become seriously injured, ill or dies while under Quail Ridge care, Quail Ridge agrees to notify mare owner or his/her authorized agent immediately.
- 7) Quail Ridge agrees to exercise their best judgment in the care and supervision of the mare/foal while said mare/foal are under Quail Ridge care. Mare/foal will be maintained in good condition using the usual and reasonable standards and practices of animal husbandry and the horse industry.
- 8) Quail Ridge agrees to diligently try to settle the mare, however if the mare fails to settle for any reason, mare owner will hold Quail Ridge and stallion owner blameless. Mare owner agrees to give Quail Ridge ample opportunity to settle the mare. Should mare die or become unfit for breeding, this contract will become null and void.
- 9) Quail Ridge Ranch reserves the right, at their sole discretion to accept or decline to accept another mare as substitute for a rebreed option if the above names mare was pronounced in foal after breeding. Mare owner agrees that NO refund of the stallion service fee will be made unless the stallion dies or becomes permanently unfit for breeding prior to the mare being declared in foal. Upon such occasion, all stallion service fees will be refunded to mare owner, and this contract will become null and void.
- 10) Mare owner will be responsible for all semen collections and AI fees.
- 11) Mare owner agrees to pay all court costs, including reasonable attorney's fees, if any legal action is required to enforce any provision of this contract. The terms of this contract shall be governed by the laws of the state of Idaho.
